4. What You Are Consenting To

- Receive, store, review, and analyze photographs of the minor's skin (face or other body area as submitted) for the sole purpose of generating the AI Skin Review and the written wellness plan.

- Permit Niya D. Pennie, BSN, RN (TX RN License #1076948) to personally review the minor's photos and intake details before delivering the plan.
- Email the completed wellness plan to the minor's email address and / or to the parent's email address, at the parent's choice.
- Retain the minor's photos and health intake details for up to 90 days after plan delivery, then delete them, in accordance with the Radiant Revive Privacy Policy.

5. Acknowledgments

- **Wellness coaching, not medical care.** I understand that Radiant Revive's current Phase I services are wellness coaching and skincare education, NOT medical care. No diagnosis, prescription, or treatment is being provided. The AI Skin Review and personalized plan do not replace evaluation by a licensed dermatologist, pediatrician, or other healthcare provider.
- **Not an FDA-cleared medical device.** The AI tool is an educational and informational tool. It has not been evaluated or cleared by the U.S. Food and Drug Administration for the diagnosis or treatment of any condition.
- **Privacy and data handling.** I have reviewed the Radiant Revive Privacy Policy at radiantrevivemedspa.com/privacy.html and understand how the minor's photos and personal information will be collected, used, stored, shared, and deleted.
- **No emergency service.** I understand that Radiant Revive is not an emergency or urgent care service. In a medical emergency I will call 911 or go to the nearest emergency room.
- **Right to withdraw.** I may withdraw this consent at any time by emailing info@radiantrevivemedspa.com. Upon withdrawal, the minor's photos and intake details will be deleted within 30 days, except as required by law.
- **Truthfulness.** I confirm that I am the lawful parent or legal guardian of the minor named in Section 2, that the information I have provided is accurate, and that the minor is using this service with my permission.

6. Identity Verification

To verify that the parent or guardian signing this form is who they claim to be, Radiant Revive requires a clear photograph or scan of a valid government-issued photo ID (e.g., driver's license, state ID, or passport) for the parent / guardian only. The ID will be reviewed by Niya, RN solely for the purpose of confirming identity, and will be deleted within 30 days of verification. The ID will not be used for any other purpose, shared with third parties, or retained beyond that period.

HOW TO SUBMIT THIS FORM

Pick whichever is easier — both work the same.

Option A — Upload through the intake form (fastest):

Sign this form, then scan or take a clear photo of all pages. Go to radiantrevivemedspa.com/ai-intake.html, find the parental consent section, and use the upload boxes under Step 3 to attach (1) this signed form and (2) a clear photo of the parent / guardian's government-issued ID.

Option B — Email it to us:

Sign this form, then email a scan or photo of all pages PLUS a clear photo of the parent / guardian's government-issued ID to info@radiantrevivemedspa.com.

Subject line: Minor Verification

Include in the email body: the minor's full name and the order / payment confirmation number (so we can match it to the right intake).

What happens next: Radiant Revive will review your submission and confirm verification by email within **24–48 hours**. Once verified, Niya, RN will personally review the minor's photos and intake, and send the custom plan within an additional 48 hours.
